#### **Opening**

The two days Mentorship training of trainers workshop was opened with a Self-Introduction under the PHD director coordination of workshop objectives, followed by welcome statement by the Technical Advisor of the DG Dr Amal Ali who proceeded the presentation by facilitators from AFENET and WHO on 22<sup>th</sup> to 23<sup>th</sup> August 2023. Ten Senior Public Health officers of the MoHD attended the two days Mentorship trainers of Training.

Abdi Hergeye followed by the remark by Dr. Deq Saeed Jama WHO representative, Dr. Dr. Bonheur Dounebaine (virtual), Mrs. Rosita Wigand, Dr Tatek Bogale AFENET Horn of Africa Regional technical Coordinator. The Expectation and Objective of the Frontline FETP presented By Dr.Amal Ali.

All congratulated the participants for joining the program and emphasized the importance of the program in strengthening public health emergency management in their respective levels.

#### Introduction

FETP Frontline Surveillance Training (FETP-Frontline) is a 3-month in-service program focused on detecting and responding to diseases and events of public health importance or international concern. Participants spend up to 12 days in three workshops in the classroom; they spend the remaining 8–10 weeks back at their jobs, where they conduct field projects to practice, implement, and reinforce what they have learned. These projects include creating a report with summary tables and charts of the surveillance data routinely collected at their agency; conducting monitoring, evaluation, and feedback visits at some of the reporting sites; performing a health problem analysis; and participating in a case or outbreak investigation.

#### **Objective**

- ❖ To reinforce participants' current responsibilities and prepare them for the program's field activities.
- Highlight descriptive epidemiology skills that improve practical surveillance and data management skills
- \* Recognize the importance of collecting and summarizing / reviewing surveillance data regularly to monitor health conditions in the community and to provide information for public health decision-making
- Conduct monitoring and evaluation of surveillance data collection, analysis, and reporting
- ❖ Teach basic data auditing skills and use of data auditing tools to improve surveillance data quality at all levels

**Training Days:** The training was conducted for Five days; from Sunday 26<sup>th</sup> to Thursday 25<sup>th</sup> August 2023

Training Place: Maansoor Hotel, Hargeisa, Somaliland

Each participant is assigned to different districts to conduct their field project and strengthen Surveillance system. They are expected to conduct assessment of the quality of local data, with recommendations for improvement and Surveillance summary report that can be used for public health decision making. Each participant has assigned mentor and co-mentor to help them throughout the three month period.

**Training Facilitators:** Trainers/facilitators were from experienced field epidemiologist from AFENET and WHO.

**Participants**: A total of 10 participants (All male) from Regional level participated in the first workshop. Participants were public health officers and HMIS officers from Regional level Ministry of Health. (Table 2)
